This event will mark the launch of the *Full View: Ensuring a comprehensive approach to achieve the goal of gender balance in the UNFCCC process.* This research report was produced by UN Women and the Mary Robinson Foundation – Climate Justice. It examines developments in the equal participation and representation of women in decision-making processes and provides a number of targeted recommendations for stakeholders to realize the goal of gender balance, as well as important complementary measures and actions to achieve gender equality and ensure the systematic integration of a gender perspective in all the thematic workstreams of the UNFCCC. This is the second edition of the *The Full View* and builds on the report published in 2013 which highlighted best practices and lessons learned from various sectors to promote women's voice and agency. This second edition examines developments in the equal participation and representation of women in decision-making processes. It provides recommendations for different stakeholders to realize the goal of gender perspective in all the systemations for different stakeholders to realize the goal of gender balance. It also highlights complementary measures and actions to achieve gender equality and ensure the systematic integration of a gender perspective in all thematic work streams of the UNFCCC.
